- * A deposit must accompany each child's application: \$500 per child (1-week sessions: \$250).
- * Sibling discount: You may deduct \$100 from the second child and \$150 for each additional child.
- * Registration cannot be processed without full deposit plus payment plan for all fees due at time of registration.
- * For JCC members, membership dues must be current to register for camp. Dues must also be current throughout the length of camp sessions. Delinquent balance must be paid in full or payment arrangements made before any new registrations are accepted.
- * To qualify as a non-member, primary residence must be more than ten miles from the JCC.
- * On January 20, 2017, 1/3 of all camp fees are due; on February 20, 2017, 2/3 of all camp fees are due. All camp fees, including payment plans, be paid in full by March 20, 2017. 3% discount will be applied to all registrations paid in full at the time of registration.
- * Cancellation prior to March 1, 2017 will be refunded in full. Cancellation prior to May 1, 2017 will receive 50% refund. Cancellation after May 1, 2017 will receive 25% refund.
- * There is a \$25 service charge on returned checks, rejected credit cards or insufficient funds.
- * Failure to meet payment schedules will result in loss of all early bird and membership discounts, as well as space in camp.
- * Camp fees are NON-TRANSFERABLE.
- * To ensure the best possible summer camp experience, please note that ALL CELL PHONE AND ANY OTHER COMMUNICATION DEVICES are not permitted at camp and will be confiscated immediately.
- * There is no pro-rated fee for campers arriving after the start of the session or leaving before its completion, nor any refunds for campers who are dismissed for inappropriate behavior.
- * Parents/guardians are responsible for all medical charges incurred by campers during camp including, but not limited to, prescription medication, hospital services, emergency services, and ambulance. These charges will be billed separately and are not included in camp fees.
- * I understand that all camper spaces are processed and assigned by grade, on a "space available" basis, at the time of registration.
- * Camper photos and comments may be used for publicity without compensation or prior consent.
